Synergy Green Industries Ltd is pleased to update you the business performance for first three months (Q1) of FY 2019-20 as per following:

1. Sales Revenue increased by 24.2% to Rs 50.76 Crores as compared to Rs 40.87 Crores during corresponding first quarter of FY 2018-19.
2. Absolute PBDIT figures increased by 117% to Rs 6.52 Crores as compared to Rs 3.01 Crores during corresponding quarter of previous year.
3. Company has got healthy executable order book/schedules for FY 2019-20 to achieve 40% revenue growth over previous year.
4. During recent floods in Kolhapur, plant is completely safe. However, one-week production got impacted due to raw material, electricity and employees. Capacity expansion activities are also marginally got affected. Production from new facility is expected to start during Oct 19.
